Dear Chairman Burnett:

I am writing to request formal government-to-government consultation for the projects listed in the attachment. Tribal views are an important part of our analysis as we work with grant recipients toward implementing these projects

Where state funding is involved, we are seeking this consultation in accord with the Governor's Executive Order 05-05 on Archeological and Cultural Resources. Where funding through the federal Land and Water Conservation Fund is involved, we are seeking consultation under the authority delegated to our office by the National Park Service under federal Executive Order 12372, the National Environmental Policy Act and Section 106 of the Historic Preservation Act. The National Park Service retains legal responsibility for Section 106 determinations.

The listed projects have diverse objectives, including planning for future projects; acquiring land or property rights, in some cases for future development; and maintaining or developing facilities; and restoring habitat. More information on these projects is available by visiting, http://www.rco.wa.gov/rec&cons_ez_forms.shtml and/or contacting the staff listed. As noted on the last page of the list, we have omitted some projects, including those with little chance of receiving funds, those not involving ground disturbing activities, and those where other agencies must consult with the tribes on cultural resources issues. If you would like a list of these projects, just let us know.

To help us determine which projects should proceed, I would very much appreciate your response to this letter in the next 30 days. It would be especially helpful if you could tell us:

- 1. For which of these projects, if any, does your tribe have cultural resource concerns?
- 2. What, if any, known cultural resources would be affected?

- 4. Who would be our primary contact with your tribe?
