In addition, we worked through a local agreement with Chelan PUD, continued process for the water right change application, and made good progress on the funding wrap up. Cultural Resources surveys were also completed on the project.
3 of 4	Do you anticipate any changes to your project? Please describe those changes here.	Yes	Potentially, we are currently working on a scope change to the project, We are analyzing a point of diversion change from the lower .5 miles of the Wenatchee instead of from the Columbia. We are moving towards a new point of withdrawl on the lower .5 miles of the Wenachee River, because it would provide nearly the same biological benefit, save on project costs, reduce cultural resource risks and help in long term management of the diversion for Piooner Water Users We are working with the RTT to vet any concerns, but there should be little affect to the originally proposed benefits to this project from the scope change. I will make sure to coordinate as we try to make determination on this.
