

INTRODUCTION

PURPOSE and SCOPE

This Phase I Environmental Site Assessment (ESA) of the Fromm Icicle Creek Property (Subject Property) was prepared for the Chelan-Douglas Land Trust in conformance with **ASTM E 1527-05 Standard Practice for Environmental Site Assessments: Phase I Environmental Site Assessment Process**, which is in full compliance with the EPA standards and practices for the "All Appropriate Inquiry" (AAI) Final Rule, 40 CFR Part 312. The purpose of the ESA is to determine if the Subject real property and improvements exhibit any recognized environmental conditions (such as the presence of any hazardous substances or petroleum hydrocarbon products) that indicate an existing release, a past release, or threat of a release into the ground, groundwater, or surface water of the property.



The Fromm Property (Subject) is located on Icicle Creek within the southwest quarter of Section 13 (Township 24 North, Range 17 East W.M.), immediately south of the incorporated limits of Leavenworth, near the confluence with the Wenatchee River. The Subject consists of two discontinuous floodplain riparian parcels, separated by Icicle Creek, at an approximate elevation of 1,123 feet. Parcel A, approximately 10 acres, is on the west side of the Creek; and Parcel B, approximately 5 acres, is on the east side. Both Parcels have diverse riparian vegetation and shoreline access.

Parcel A is a rounded square field and peninsula property, roughly 750 feet per side, with east and north shoreline frontage on Icicle Creek. The Parcel is isolated from public access by the Creek and private property on the west and south boundaries. The Property is accessed off Highway 2, through Leavenworth, left on Icicle Creek Road for about 1 mile, turn left on Wilson Street and follow to the end of the road on (private) Fromm property. Continuing access is gated.

Parcel B is an elongated triangular shaped parcel, approximately 0.25-mile long by a few hundred feet wide at the widest (northern) boundary. The west boundary of Parcel B consists of Icicle Creek frontage and East Leavenworth Road provides the eastern boundary. Property is accessed off Highway 2, by turning left just before the Wenatchee River Bridge in Leavenworth, travelling south on East Leavenworth Road for about 2 miles. Parcel B Subject is located on the right side of the road with several gravel turnouts.

Subject Soils

Soils within Parcel A are mapped by the NRCS as (Le) Leavenworth loamy sand, and within Parcel B as (Lh) Leavenworth fine sandy loam. Both soils have similar physical qualities: shallow water tables, moderately well drained, sand rich soils derived from alluvium; although the soils found on Parcel B have a slightly finer grain sand component. A Soils Map is provided as an attachment to this report.

Regional Geology

The north-south trending Leavenworth Fault, running through the general vicinity of Icicle Creek through the Subject, separates the younger Chumstick Formation to the east from the Mt. Stuart granite batholith to the southwest. The Subject is underlain by sediments derived from glacial activity and weathering of bedrock (primarily the granitic batholith) that forms the upper watershed of Icicle Creek. A Regional Geologic Map is provided as an attachment to this report.

Icicle Creek originates in the Alpine Lakes Wilderness Area and discharges to the Wenatchee River at Leavenworth, just north of the Subject Property. Annual mean flow is about 600 cfs with peak flows ranging from about 1,000 cfs to over 10,000 cfs, typically in May-June.

Majority of the Subject is located within the 100-year floodplain in AE zones with listed flood elevations of 1,112 to 1,115 feet. The area has had significant study, with flood cross sections passing through the Subjects, likely impacted by backwater effects up Icicle Creek from the proximity to the confluence of the Wenatchee River.

The National Wetlands Inventory (NWI) map shows no wetland development on the Subject Parcels. High quality forested/shrub wetland areas are mapped just south of Parcel A and across Icicle Creek from Parcel B.

Water quality studies for the Wenatchee River Watershed (Water Resource Inventory Area 45) include Icicle Creek on the 2008 Water Quality 303(d)-5 List (impaired surface water) for PCBs, pH, and dissolved oxygen.








AERIAL PHOTOGRAPHS

1998 Black and White Aerial Photograph (Google): This aerial photograph shows Subject features similar to existing conditions, however Parcel A appears to have a larger peninsula, and Parcel B appears to be wider with a sandbar near the north boundary. No evidence of potential recognized environmental conditions (RECs) is observed at the scale of the photograph.





2005 Color Aerial Photograph (Google): This color aerial photograph shows Subject features similar to existing conditions, and little observable changed in surrounding land use from previous aerial photographs. No evidence of potential recognized environmental conditions (RECs) is observed at the scale of the photograph.






BLM Lands Records – 1892 Cadastral Survey:

The 1892 Cadastral Survey shows less meander in Icicle Creek. The big bend that borders the north side of Parcel A has not been formed. David C. Wilsen has a cabin above Parcel A on the Creek. There is a road or trail in the approximate vicinity of the East Leavenworth Road with more east west width for Parcel B.



Chelan County Assessor Historic Section Map:


The Chelan County Assessor Historic Section Map (dated approximately in the 1960s) shows Fromm as the landowners of the Subject Parcels and a major landowner south of Leavenworth. The meander bend is in place at Parcel A and Parcel B looks slightly larger, suggesting that Icicle Creek may be migrating to the east and potentially north.



Bureau of Land Management (BLM) Records

- 1907 Cadastral Survey: Survey of remaining sections within the township and range. Shows pipe line and flume moving into the northeast quarter of Section 14.

The Bureau of Land Management (BLM) Landrecords Database (LR2000) was reviewed for active, closed, pending, and void mining claims within Township 24 North, Range 17 East W.M. Query results for BLM lands are provided as an attachment to this report. No active, pending, or void mining claims are reported from database queries for the entire township and range. No claims (of any status) are recorded for Section 13, and several closed claims are reported for Township 24 North, Range 17 East W.M. within Sections 25, 28, 30, and 36 (attached).

Surface mining permits for current operations, issued by Washington Department of Natural Resources for Chelan County, were reviewed for the area around the Subject Property. No permits are recorded for the entire township and range. However, the Owners' representative described prior gravel bar extraction under permit in the *Chelan-Douglas Land Trust Environmental Screening Questionnaire* (attached).







Washington State Department of Ecology Facility/Site Identification System

The federal database search results were also compared (for completeness) with the Washington State Department of Ecology's Facility/Site Identification System database (http://www.ecy.wa.gov/services/as/iss/fsweb/fshome.html), which provides better radius searches and results closer to the Subject). The state database includes federal environmental site data and state listed contaminated sites, hazardous waste generators, fuel underground storage tanks (UST) and leaking underground storage tanks (LUST), landfills, water quality permits, and dams. These were queried using the database mapping functions to locate

reported sites near the Subject Property. (Note: It is common for the actual facility/site locations to differ from reported locations due to reading, datum, and unit errors).



Stuart.
