## # Question Answer **Answer Description** 1 of 4 Are there any significant challenges that might hinder No progress or keep you from meeting your project milestones? If so, please tell us about them. 2 of 4 Describe the work accomplished during this reporting RFQ released and 7 SOQ received. Two finalists were selected after consultation with local Yakima bull trout technical work group. After personal interviews with finalists Natural Systems Design was awarded the environmental consultant contract. Detailed scope of work and budget were drafted and approved. Historic Gold Creek studies and data were compiled, organized and reviewed then an inventory posted to FTP. Assessment plan for hydrologic surface and subsurface data gathering was created. Proposed map of monitoring well locations reviewed by Technical Work Group 5/9/2013. Final map of monitoring well locations produced by NSD (ATT# 28). Landowners have been contacted about wells and instrument locations, installation plans, and monitoring schedule. Agencies with jurisdiction are being contacted about potential permit requirements for surface and subsurface instrument installation and monitoring. 3 of 4 No Do you anticipate any changes to your project? Please describe those changes here. 4 of 4 Tell us about work planned for the next reporting period. Install water elevation monitoring instruments at surface and subsurface locations as mapped. GPS locate all instruments and staff gages. Continue landowner outreach and public education efforts. Data will be gathered throughout 2013 with a focus on late season low flow periods when dewatereing is a problem. Monitoring data will be integrated with field work and analysis into a draft geomorphic assessment. Field work and habitat features inventory will be combined with geomorphic assessment information to begin drafting the

habitat assessment technical memo.
