DESCRIPTION OF THE COMPLETED PROJECT

The goal of this acquisition project was to protect the natural shoreline processes, natural habitat, water quality, and native shoreline vegetation of the target property on Reid Harbor, Stuart Island for endangered outmigrating juvenile Chinook salmon; juvenile chum and pink salmon; surf smelt; Pacific sand lance; and Pacific herring. This acquisition project protected the target property through purchase of a Conservation Easement ensuring permanent protection and extinguishment of up to 10 development rights on approximately 61 acres and 4,389 feet of natural shoreline which is located in a high priority Fish Use region in the San Juan Islands. This high priority property anchors the forested medium bank southern shore of Reid Harbor with mixed old growth and second growth. This shoreline has eelgrass beds and habitat suitable for forage fish spawning. In addition to being identified as a high priority location for salmon recovery, the San Juan Preservation Trust has designated the area around Reid Harbor as a priority for conservation and with Washington State Parks has already protected over 355 acres in close proximity to this project, including much of the watershed surrounding the harbor. With adjacent and nearby parks and conservation land already set aside, this project extended total protection along the shores of Reid Harbor to over 13,800 feet of shoreline (approximately 60% of the entire harbor).

### **PROJECT NARRATIVE**

Project History: Project Start date was August 22, 2013. The Conservation Easement was signed/recorded December 31, 2013. Project Changes: Project Changes included adjustment of the purchase price based on final appraised value and an increase in reimbursed administrative costs. This past winter one of the pocket beaches on the conservation easement was surveyed for forage fish eggs and surf smelt spawning was documented, adding further confirmation of the project's high value fish habitat. Grantor name was changed to "Northstar Preserve LLC". Final adjustments were made to the siting and design of Structures Areas #1 and #2, consistent with protection of conservation values.

Lessons Learned: Lessons Learned include the importance of having a committed, conservation-minded grantor and a responsive team, including project manager. Having this great group of people to work with made it possible to meet grant requirements within relatively short timeframes.

Project Outcome: The project was successfully concluded as planned.
