PROJECT SUMMARY

This 34-acre property located on Waldron Island in San Juan County includes a large area of undeveloped natural shoreline, bordered on each side by private lands already protected by conservation easements. This is highest priority fish use area. This project proposes to eliminate 4 of 6 existing development rights and protect 2,525 feet of shoreline. Total project cost is \$337,000; SRFB ask is \$286,400.

Since the site visit gave only the offshore perspective and did not allow us to access the property, it would be helpful to know more clearly the extent of the acquisition and the condition of the vegetation. The inclusion of on-the-ground photos of the site would be helpful, including the natural features and existing structures/clearing on the property. If possible, additional photos looking onshore (and/or aerial oblique images from Bing for example) with mark ups to show the margins of the conservation easement property would also be helpful.

3. Comments/Questions:

The parcel contains a large section of intact exceptional feeder bluff which creates and sustains shoreline habitats throughout the several mile-long drift cell. The conservation easements on the adjacent properties on either side of the proposed project add terrific value by the creation of a contiguous block of protected shoreline.
