This proposal will complete a preliminary engineering design and permitting for the day-lighted channel component of a large, multi-phased project to restore tidal processes and Chinook rearing habitat in the Edmonds Marsh. A key aspect of the preliminary design is determining how the channel design will accommodate the on-going hazardous substance remediation commitments at the Unocal/Chevron property.

The review panel provided extensive technical review comments for the final feasibility study phase of this project (SRFB Project No. 13-1107). The current proposal provides valuable information that has been developed since 2013 on fish utilization, coastal geomorphology, and other relevant issues. This recent information addresses questions and concerns identified in last year's review, and strengthens the overall outlook for the benefit and certainty of the project.

The proposed work is technically sound and is an appropriate priority in the overall sequence for developing the the larger Edmonds Marsh project. The review panel recommends that the sponsor likewise elevate its negotiations

over purchasing (or otherwise obtaining a controlling interest over) the Unocal/Chevron property to an immediate priority. Control over this property will allow more flexibility in designing the alignment and habitat features of the new channel. For example, it potentially could allow for a wide setback from the railroad tracks, which could be planted in a substantial buffer of native nearshore vegetation. The sponsor may find it useful to engage the Puget Sound Partnership to help it advocate in negotiations with Ecology, WSDOT and the landowner over the certification of cleanup and eventual transfer of control over the Unocal/Chevron property.
