Progress on this project has been delayed while the City of Edmonds completes a public engagement process to redesign Marina Beach Park to include the daylighted tidal channel for Willow Creek reconnection to Edmonds Marsh. To date, the City has held three public meetings and hosted an online open house forum to gather community input on the project. The final draft conceptual plan for the park, including the tidal channel, will be presented to City Planning Board on August 12th and then City Council for final public hearing and adoption on August 18th. The final plan will be submitted in September. At the point, work will proceed on this project- Willow Creek design. It is worthwhile to mention that there is broad support from the community and elected officials to daylight Willow Creek through Marina Beach Park as part of the park redesign.

Due to this challenge and setback in project progress, some project milestones will be delayed. However, we fully anticipate staying on target with completing this project on time.
