Project Description

The Adopt A Stream Foundation (AASF) is requesting funds to generate preliminary design deliverables focused on improving habitat conditions in a future restoration project. Grant funding will be used to complete preliminary designs (as described in Manual 18 Appendix D-2) for the second phase of stream restoration at the Friendly Village Mobile Home Park in Redmond, WA along Bear Creek Reach 6. AASF will create a Request for Proposals (RFP) and select a qualified consultant that will be responsible for topographic surveying, hydraulic analysis, preliminary and final designs, cultural resource consultation and permitting assistance. AASF will work closely with the consultant and the landowner to develop designs that will provide the maximum benefit to fish and be acceptable to the landowner. The design completed with this current funding request will be used for a future restoration project that will directly address priorities for Bear/Cottage Lake Creeks in the WRIA 8 Conservation Strategy for Chinook salmon (threatened), including protecting and restoring riparian vegetation and floodplain connectivity. This project will address these habitat-limiting factors by focusing design on: installing Large Woody Debris, re-vegetating the riparian buffer, increasing flood plain connectivity and re-establishing stream processes. Stakeholders in the design process include: AASF, WRIA 8, permit agencies, and Friendly Village Park landowner.

Worksite Description: The project starts at Snohomish Drive and continues downstream along Bear Creek for 330' and includes both banks for a total planting area of 1.0 acre. The existing streambanks are nearly vertical with extensive erosion occurring along each bank (see attached photos). The bank erosion is exasperated by the lack on native vegetation with both banks having manicured lawns to the edge of the stream. There is a footbridge that crosses the creek about mid way through the project area.
Activities: The major actives at this site will include: topographic surveying, hydraulic analysis, preliminary designs, and permitting

Current land use is a mobile home park bisected by Bear Creek. Prior human use at this site is unknown by the applicant. The site was probably logged in the late 19th or early 20th century like the surrounding area and may have been used for agriculture. Surrounding parcels show evidence of agricultural use. Bear Creek is used by most Pacific Salmon species including Chinook. This site is likely used by some salmon species for spawning, and is known as rearing habitat and is utilized for salmon migration.
