Special Conditions

A. Compliance with EO 05-05, Archaeological and Cultural Resource Consultation: Survey Required

This project includes ground disturbing activities and is required to undergo cultural resources consultation in accordance with Governor's Executive Order 05-05 Archaeological and Cultural Resources Consultation, as described in Section 9 of this project agreement. RCO has completed the initial consultation for this project, and a Cultural Resources Survey is being required by Department of Archaeology and Historic Preservation or a Tribe. Completion of this survey and a Notice to Proceed from RCO will be required before any ground disturbing activities can begin.

In the event that archaeological or historic materials are discovered during future ground disturbing activities, work in the immediate vicinity must stop; the area must be secured, and the Sponsor must notify the concerned tribe's cultural staff and cultural committee, the Recreation and Conservation Office, and Department of Archaeology and Historic Preservation. (Inadvertent Discovery of Human Skeletal Remains on Non-Federal and Non-Tribal Land in the State of Washington (RCWs 68.50.645, 27.44.055, and 68.60.055))

B. Design and Restoration Project Deliverables: The project will meet the standards for Design and Restoration Project Deliverables described in Manual 18 Appendix D-4 "Construction and "Design Build" Deliverables." During 2012 grant proposal review, the sponsor submitted Conceptual Design Plans (PRISM Attachment 10), and therefore will complete three remaining project development stages and provide the associated deliverables for each. The following must be submitted to RCO:

- 1) Preliminary Design Deliverables (See Appendix D-2 for additional details):
 - a) Preliminary Design Report, Drawings, and Engineering Cost Estimate;
 - b) Design Review Comments (optional); and
 - c) Permit Applications (optional).
- 2) Final Design Deliverables will be provided to RCO before construction: (See Appendix D-3 for additional details):
 - a) Design Review Comments;
 - b) Final Design Report and Drawings incorporating comments provided by stakeholders, SRFB, and/or permit agencies regarding the preliminary design report and on-site review.
 - c) Final Construction Quantities and Costs;
 - d) Construction permits.
- 3) Post Construction Deliverables(See Appendix D-4 for additional details):
 - a) "As-built" Drawings.
