1 of 5	Are there any significant challenges that might hinder progress or keep you from meeting your project milestones? If so, please tell us about them.	Yes	The project team is addressing Technical Committee's recommendations that arose from the site visit for project application 16-1214. The recommendations we are proposing to address are 1. consider feasibilty of an alternative daylight creek alignment across the Unocal property that would provide better habitat conditions, 2. conducting a sea level rise/climate change impact assessment, and 3. conducting a water quality/storm water assessment. The project team believes we should consider the feasibility of an alternative alignment, so as not to spend funds designing a lesser quality alignment when a better alignment is feasible and preferred. The project team is prepared, with RCO approval, to provide an alternative scope of work for this project phase to address all three recommendations listed above. If approved, the project team is poised to begin work immediately.
