1 of 5	Are there any significant challenges that might hinder progress or keep you from meeting your project milestones? If so, please tell us about them.	Yes	Delays in contracting occured during the last quarter of 2016 and two milestones therefore have new target dates.
2 of 5	Describe the work accomplished during this reporting period.		Consultant team has been hired by the City. Field data collection preparations are complete, such as gathering standards, calibrating equipment, and determining methodologies. Consultant team completed first of four water quality samplings. Consultant developed three "strawman" conceptual plans of alternative alignments across the Unocal property, one showing the current straight, narrow alignment, and two additional concepts showing channel pulled east away from BNSF RR, added channel sinuosity and varying buffer widths. These three alternative concepts were presented to representatives of WSDOT Ferries Division at a meeting with key City staff and consultant on 12/20/16. WSDOT Ferries representatives expressed their interest in working collaboratively with the City on possible alternative channel alignments.

4 of 5	Tell us about work planned for the next reporting period.		The Consultant team will complete water and soil quality sampling, including required Cultural Resources review. The consultant team will finalize two conceptual alternative alignments based on discussion at the 12/20 meeting with WSDOT Ferries. This will include hydraulic modeling and fish habitat summary of an alternative alignment. A comparison of increased habitat area and projected value provided with an alternative alignment will also be assessed. A conceptual design report of the two alternatives will be provided. In collaboration with the City and WSDOT Ferries, consultant team will finalize a preferred alternative alignment and develop a restoration plan, grading plan, cost estimates of preferred alignment.
