#1: Describe the work accomplished during this reporting period.

Description is required

All critical areas including streams, wetlands, and geologically hazardous areas were delineated, flagged and surveyed within the project area and confirmed by the local permitting agency. A draft critical areas report has been prepared. The boundary and topographic survey was completed for the project area. Five piezometers were installed in the proposed estuary area for purposes of monitoring groundwater levels over the course of the year. The geotechnical investigation was conducted on the access road which is anticipated to be used for construction mobilization. A boring was completed for the proposed pedestrian bridge over the creek. The BNSF temporary license for investigative work within BNSF right of way was finally obtained in March after continuous delays by the 3rd party overseeing r/w permits for BNSF. At the request of our railroad consultant, a BNSF official stepped in on the County's behalf and we had the permit within weeks. Investigative studies within the railroad r/w including ground penetrating radar, vertical soil borings, cultural resources survey, and topographic survey were conducted. Consultants successfully coordinated all operations with designated BNSF flagger. A cultural resource specialist was on-site during all earth disturbing activities as warranted. Thirty percent railroad bridge design commenced.

Complete investigative studies including cultural resource survey, a horizontal boring will be drilled through the embankment to confirm findings from the GPR. Several meetings are proposed for this period, including consultant updates to county as well as request for Preliminary design input for habitat; with a separate meeting scheduled for park elements; Community and Organization/Agency stakeholder meetings are scheduled for June-August.; Bridge plans will be completed to 30% for submittal to BNSF in July/August with anticipated review comments received prior to final submittal of design report to RCO; Preliminary design to be completed for submittal by 12/8/17.
