#### #2: Site Visit Summary

Inspection complete. The plants look great and their survival in commendable, especially consider the 2 years following planting were record dry years. They left it up to the contractor to decide how they wanted to water. The contractor chose to use a drip irrigation system (ACCD did not pay it). They drove in with a water truck and hooked up to the drip irrigation hoses. They watched weather reports and watered as needed. Weeds were the biggest challenge. Chokecherries and juniper did best; Doug fir did the worst (38% survival in tarps). Lesson learned: more weed control ahead of planting would have helped.

SF Asotin Cr: They planted within and outside of tarps. Where soil was deep enough, they tilled and rototilled, laid tarp in the fall, then planted in the spring. 100% of plants in tarps survived; survival was less outside of the tarps, but still good. Plants within the tarp also had a much higher growth rate, which increased with proximity to the stream.

Charley Cr: In non-tarped areas, plants along the fringe of wooded areas did best. There was higher herbivory along tarps, presumably because they provided easy access to highly visible plants.
