This included extensive conversations through phone calls and emails as well as an onsite meeting with the new landowner King County Housing Authority (KCHA). At times I was doubtful that I would be able to secure a new LOA but after several months of conversations and an onsite meeting with representatives from KCHA, AASF, Chinook Engineering, and the City of Redmond I obtained an executed LOA from KCHA. Although the major accomplishment for this reporting period was obtaining a new LOA other essential project tasks were preformed. Project permit applications were started, I also deliberated with the project engineer on details specific to the project construction. Essential equipment for the project was checked and repaired as necessary including fish exclusion nets, dip nets, roto hammers, and back pack shocker. I per-ordered materials from our wood supplier who is currently stock piling LWD for this project.
