#1: Describe the work accomplished during this reporting period.

Following receipt of adequate matching funds, NWSF and CGS completed the final design, development of construction specifications, and bid documents. The project was advertised for bidding in June and a pre-bid meeting was held. No contract was awarded.

#2: Are there any significant challenges that might hinder progress or keep you from meeting your project milestones? If so, please tell us about them.

Changes to the design were made by CGS in the final design process to modify and reduce the impact of the slope protection elements. This resulted in delays to the bidding schedule (originally planned for March 2019) as permit modifications were necessary to ensure regulatory agencies were informed of and approved the changes. The pre-bid meeting was mandatory due to the complexity of the site and restricted access by land through private property.

At the pre-bid, contractors expressed concerns about the cost estimate of the project as it relates to the number of barge trips required due to the shallow nature of the site. The timeline for completion was also a concern due to limited barge availability at this time of year. We received only one bid and that was from an unqualified bidder due to their lack of attendance at the pre-bid. The project will need to be re-bid with some changes to proposed methods of removal and a revised cost estimate. The location of the project at the toe of a feeder bluff requires this project be completed during dry summer months. This will delay the work until summer of 2020. NWSF needs to request an extension of the grant period to allow for construction next summer. We are requesting an extension through December 2021 to allow for one year of post-restoration monitoring under the ESRP funded portion of the grant.

#3: Tell us about work planned for the next reporting period.

NWSF and CGS will reassess the cost estimate for the project and modify the bid documents in preparation for bidding in February or March of 2020. This proposed schedule was verified as ideal through discussions with two different contractors who attended, but did not bid on the project.
