The sponsor is encouraged to work with the federal permitting agency to align the Section 106 APE with the scope of work subject to this project agreement. Before initiating any ground disturbing activities described in this agreement, you must submit evidence of completion of the Section 106 consultation to RCO and receive your Notice to Proceed. The lead federal agency should be able to provide you the necessary documentation.

**b) Design Deliverables:** The project will meet the standards for Design and Restoration Project Deliverables described in Manual 18 (2018) Appendix D-4 Construction Deliverables. The preliminary designs were submitted as part of the SRFB grant application process and are attached to PRISM. The sponsor submitted draft final designs to the WRIA 8 Technical Committee for review, and recommendations were incorporated into the final designs which are attached to PRISM. The sponsor will submit As-built Drawings upon completion of the restoration project.
