Special Conditions

1 - The SRFB technical review panel requests that the rock wall and stair access be minimized to the extent possible in terms of the length of shoreline. Further, the panel emphasizes that the rock wall is not intended to stabilize the slope above and will not likely prevent movement of the path surface.

2 - ESRP funds, totaling \$46,815 are used as match, and indirect costs are not eligible to be reimbursed from these funds.

3 - PSAR funds must be expended by 6/30/2021.
