#1: Describe the work accomplished during this reporting period.

Work continued on developing conceptual design facilities at the Dryden location. Work was initiated on the expanded pump exchange to identify additional pump station locations to enable a full season pumping project. Site visits were made in August with stakeholders to identify several alternatives. Site investigations occurred in November to collect stream flow and depth at potential pump station sites with the use of an ADCP. This will establish bathymetry to determine the suitability of each site for pumping facilities through the full irrigation season. Engineering analyses for these sites was initiated.

- #2: Are there any significant challenges that might hinder progress or keep you from meeting your project milestones? If so, please tell us about them.

No significant challenges have been identified. The draft conceptual designs were expected in January but have been delayed a few weeks. These will be completed in February 2021.

#3: Tell us about work planned for the next reporting period.

Additional site investigations are planned for spring and summer 2021 under a separate grant. This grant will end in March 2021 with the completion of conceptual designs for the Dryden site.
