Project Proposal	Question 8 asks for alternatives considered and why the preferred was chosen. Alternatives are described, but not why the preferred was chosen.

METRICS

Page	Grant Manager Comment
Restoration Metrics	<p>Restoration metric for "Miles of Stream and/or Shoreline Treated or Protected" and "Total Riparian Miles Streambank Treated" at 0.63 miles is different than the 3,000 ft (=0.57 miles) described in Project Proposal Q. 3. These should be consistent.</p> <p>Under "Project Identified In a Plan or Watershed Assessment" please be sure to follow the endnote citation format as described. NOAA is sticker on this.</p> <p>Restoration metric for "Total Riparian Acres Treated" and "Acres planted in riparian" at 18.5 is not consistent with the 17 acres described in Project Proposal Q. 4.</p> <p>Please make sure that the Restoration Metrics and funding amounts are consistent with the attached cost estimate. For example, the cost estimate shows design work and admin, so you'll want to add a metric for A&E. The cost estimate also shows \$14K for cultural resource survey. Please add this cost metric here as well. NOTE: see Grant Manager comments further on about the Cost Estimate first - some of the cost estimate categories are under incorrect headings.</p>

Attachments	<p>COST ESTIMATE: Move "Cultural Resources" to "Construction". Make sure that the Cost Estimate and Restoration Metrics are consistent.</p> <p>COST ESTIMATE: The cost estimate includes costs for monitoring equipment/data collection. Monitoring equipment generally is not an eligible cost for restoration projects.
