Prepared and advertised RFP for construction, held pre-bid meeting. No bid received during open bid period. Proceeding to good faith negotiation with one contractor. Negotiation is still on going. We will update our grant manager when negotiations are complete.

Yes

Because we received no construction bids, we do not vet have a contractor under contract. If current negotiations are unsuccessful, we will need to re-bid the project. Project timeline may need to be adjusted to meet the new schedule.

We plan to award a construction contract and prepare for start of construction. Submit contract amendment request based on outcome of contracting.

Yes

This project's contract has an end date in June 2022. We expect to be starting construction at that time, so will request a time extension. This project had been originally planned for 2021 construction, but we constructed project 19-1718 in 2021 due to excellent channel access that was only available in 2021. We may need a scope change (reduction), and possibly a cost increase, because the quote we received in negotiations was well above our available funds.

Archaeological, Historic, and Cultural Resource Consultation

This agreement requires compliance with Executive Order 05-05 and/or Section 106 of the National Historic Preservation Act. No ground disturbing activities may be initiated until the sponsor has received notice from RCO that the appropriate cultural resource review process has been completed. Construction started without a Notice to Proceed from RCO staff will be considered a breach of contract.

Design Deliverables and Review

Final design documents, following the Brian Abbott Fish Barrier Removal Board (BAFBRB) Manual #22, Appendix C-3 requirements, must be reviewed and approved by the WDFW habitat biologist and RCO staff prior to advancing to construction. Allow 30 days for each review. The RCO will only reimburse for construction expenditures following approval of final designs.
