Pre-construction work agreement and access negotiations. Mobilized for construction but delayed the start of work because of high flows in stream.

The original scope of this project was to complete 2,100 feet of channel. Due to increased costs, we can only afford to build about 1,200 feet, so will need a scope reduction. No ground disturbing activities may be initiated until the sponsor has received notice from RCO that the appropriate cultural resource review process has been completed. Construction started without a Notice to Proceed from RCO staff will be considered a breach of contract.

Design Deliverables and Review

Final design documents, following the Brian Abbott Fish Barrier Removal Board (BAFBRB) Manual #22, Appendix C-3 requirements, must be reviewed and approved by the WDFW habitat biologist and RCO staff prior to advancing to construction. Allow 30 days for each review. The RCO will only reimburse for construction expenditures following approval of final designs.
