A. PARTIES OF THE AGREEMENT

This Project Grant Agreement (Agreement) is entered into between the Salmon Recovery Funding Board (SRFB), P.O. Box 40917, Olympia, Washington 98504-0917 and Colville Confederated Tribes, PO Box 1946, Omak, WA 98841 (Sponsor) and shall be binding upon the agents and all persons acting by or through the parties.

B. PURPOSE OF AGREEMENT

This Agreement sets out the terms and conditions by which a grant is made from the Salmon Funding Accounts of the State of Washington's General Fund. The grant is administered by the SRFB to the Sponsor for the project named above.

C. DESCRIPTION OF PROJECT

The subject Project is described on the attached Project Summary.

D. TERM OF AGREEMENT

The Project Sponsor's ongoing obligation for the above project under this Agreement is to provide maintenance of the site or facility to serve the purpose for which it was Intended for a minimum of five (5) years, or more as specified in the Landowner Agreement, after the final payment unless the site or facility is rendered unusable for the purpose it was intended by an act of nature.

E. PERIOD OF PERFORMANCE

The Project reimbursement period shall begin on July 1, 2003 and end on June 1, 2005. No expenditure made before or after this period is eligible for reimbursement unless incorporated by written amendment into this Agreement.

F. *PROJECT FUNDING*

The total grant award provided by the SRFB for this project shall not exceed \$45,000.00. The SRFB shall not pay any amount beyond that approved for funding of the project. The Sponsor shall be responsible for all total project costs that exceed this amount. The contribution by the Sponsor toward work on this project at a minimum shall be as indicated below:

DESCRIPTION:

Omak Creek, tributary to the Okanogan River, contains natural reproducing steelhead, federally listed as "endangered". However, past land management activities continue to impair aquatic habitat in Omak Creek. Unnaturally high amounts of fine sediments occurs throughout the stream, but are excessive in reaches within the upper watershed. Roads were identified as the leading factor for increased sediment yield within the Omak Creek watershed (NRCS 1995).

Road density within the Omak Creek watershed is conservatively estimated at approximately 6.35 miles/square mile (NRCS 1995). To reduce the deleterious effects of the high road density, a "ripping" technique has been implemented on road surfaces to allow infiltration and decrease the amount of sediment delivered to stream channels.

During 1999 approximately 38 miles of roads within the Omak Creek watershed were closed and decommissioned. To continue this effort, an additional 20 miles of road in the upper watershed area of Omak Creek were recommended to be decommissioned. Road sections will be selected through an inter-disciplinary team and based upon location, condition, and utility.

Monitoring will include measuring volume of fine sediment in pools. These measurements, conducted post road decommissioning, will be compared to baseline data collected during 2000.

Colville Confederated Tribes offered grant to restore land for salmon recovery.

(Omak) - Colville Confederated Tribes was awarded \$45,000 from the Salmon Recovery Funding Board (SRFB). The grant will be used for the following:

Roads were identified as the leading factor for increased sediment yield within the Omak Creek watershed (NRCS 1995). Road density within the Omak Creek watershed is estimated at approximately 6.35 miles/square mile (NRCS 1995). During 1999, approximately 38 miles of roads within the Omak Creek watershed were closed and decommissioned. This project will continue this effort, an additional 20 miles of road in the upper watershed area of Omak Creek are proposed to be decommissioned.

There were two hundred thirteen applications submitted for consideration in the Salmon Program. Each project went through an evaluation process prior to being recommended for funding. The SRFB Board approved funding for one hundred thirty-one projects on Friday, April 12, 2002.

Funding for the Salmon Program comes from the sale of state general obligation bonds. Colville Confederated Tribes will leverage local contributions totaling \$14,413 with grant monies to implement the project. Total estimated project cost is \$59,413.
