The Recreation and Conservation Office has completed review of the allowable use request for continued farming on the Leque and Roberge properties that will be acquired with funding through this office. The Tulalip Tribe and Whidbey Camano Land Trust requested approval to permit farming on these properties for a 5-year period ending March 15, 2028.

This approval is for continued farming and is conditioned on the following:

- No livestock or grazing will be permitted or occur on the properties;
- Best management practices will be followed for the use;
- Any income generated from the farming use will be used for maintaining and stewardship of the funded properties; and
- The use will end by March 15, 2028.

If there is a need to extend the use, please submit a request at least 3 months in advance of the March 15, 2028, expiration date.

RCO grants are intended to support Washington State's habitat and outdoor recreation resources. Uses of project sites must have no overall impairment to the habitat conservation or outdoor recreation resource funded by RCO.

To be in compliance with the grant, uses of grant-assisted project sites must be any of the following:


- A. Identified in the project agreement
- B. Allowed by RCO policy
- C. Approved by RCO or the funding board.

For the use to be approved by RCO or the funding board (Option C, above), it must meet all of the following criteria:

- The use must be consistent with the essential purposes of the grant (i.e. consistent with the grant agreement and grant program).
- All practical alternatives to the use, including the option of no action, must have been considered and rejected on a sound basis.
- The use must achieve its intended purpose with the least possible impact to the habitat or outdoor recreation resource.
  - If the use impacts the type of resource the grant is designed to protect (habitat, outdoor recreation), it also must provide at least equivalent benefits to that type of resource so there is no overall impairment.

An approved use of a project site must continue in the way it was approved to remain in compliance with the grant. This policy does not modify other RCO policies, such as cultural resource policies.

Income generated on the project site must be managed in accordance with RCO policies on income and income use.




20-1461 Livingston Bay Protection & Restoration Planning: Parcel Map

- Feasibility study recommends waiting to restore until Leque, Sherman, Roberge and Nelson properties acquired

### Proposed Use

- Continue farming on Leque & Roberge properties for 5 yrs
  - Prevent infestation /spread of invasive plants
  - Generate revenue to facilitate stewardship and restoration of site
- Restoration consistent with long-term restoration goals can occur on areas not currently farmed to benefit waterfowl and other natives
- Considerations
  - Proposed in currently farmed areas

### Alternatives Considered

- Restore tidal connection on properties
  - Less effective and reduced cost benefit
- Interim restoration for waterfowl/other benefits
  - Costly and would provide modest benefits over farmed conditions
- No action (not included in request, but garnered through communication)
  - Lead to increased weed management for Tribe and neighbors
  - Cost of pumping water on Leque property is 10s of \$1000s/year, which would put a strain on Tribe until property is restored

### Allowable Use

- Not Interim Use
  - Not limited to current landowner or lessee
  - 5 yrs—not 3
- Consistent-How to define?
  - Interim Use until full restoration
  - Doesn't preclude planned long-term restoration
  - Weed control
- Alternatives considered (other than no action)
- Least Impact
  - Proposed use same as current/long-term use
  - No added negative effects
- Approved similar interim use in March on 20-1139 (Snohomish Floodplain- Holy Cross Property)
