In a July 10, 2000 letter, the sponsor requested a decrease in the amount of sponsor match, a change in the source of sponsor match, and an increase in A&E from 20 to 28 percent to more accurately reflect the cost of materials, labor, engineering and other professional services required for placement of the new diversion intake, screen box, associated return flow improvements, and vegetative plantings.

Thank you for your assistance in extending the timeline for the Salmon Creek Restoration Project (Project # 99-1308D). The additional time allowed much greater flexibility in construction and placement of the remaining improvements and allowed for more timely revegetation of the disturbed bank areas.

The enclosed invoice packet represents the third and final billing under the IAC grant award as well as the signed contract amendment agreement. This billing represents the total charges for materials, labor, engineering and other professional services required for placement of the new diversion intake, screen box, and associated return flow improvements and plantings.

The Project originally was to have included placement of three in-stream structures designed to increase bank and bed stability. Implementation of these components will be delayed to allow coordination with restoration efforts planned by the Colville Tribes and others. Projected costs associated with the in-stream improvements will be covered by other funding sources associated with the Tribal restoration effort.
