Questions

#1: Describe the work accomplished during this reporting period.

SFEG contracted with ECRI to perform a cultural resoruces review. This review was completed in January and the report was provided to SFEG and submitted to RCO. Currently we are waiting for RCO to complete the consultation process so we can schedule geotech drilling.

SFEG also contracted with Chinook Engineering to provide engineering services. During this time period, Chinook Engineering prepared a communications site for handling and exchanging of data and files. We conducted an on site meeting with the Island county and our team to meet all the contacts working on the project. We reviewed the preliminary designs prepared by the Conservation District by Tom Slocum and are using those moving forward. Chinook Engineering has finalized the assembly of the base map and the topography to be a good fitting LiDAR source. Final Surveying of Right of Way to the ground will occur during the construction phase of the work. We are now preparing the installation and construction drawings for the chosen culverts for the two sites. The private crossing and the fish passage improvement at the roots will also be detailed. We have chosen to detail the concrete box culvert with a 35% countersink below the thalweg elevation for both site. This will be presented to the County for approval after the concept is reviewed. A Geotechnical contract is prepared and signed, and we are scheduling drilling on or around the July 21st date if we get locates done and the cultural resources review completed. Scott Palmer the Geotechnical Engineer and Chinook Engineering are going to meet on site on July 5th to set boring locations.

RCO has completed the initial consultation for this project and a cultural resources survey is required. The cultural resources survey must include documentation of any above or below ground archaeological resources as well as any possible historic structures or buildings that may be effected by the project. Archaeological monitoring of any proposed geotechnical borings, investigations, or test pits may be included as part of the cultural resources survey. The Sponsor must submit the results of the cultural resources survey to RCO and receive a notice of cultural resources completion. Ground disturbance started without approval will be considered a breach of contract. If archaeological or historic materials are discovered while conducting ground disturbing activities, work in the immediate vicinity must stop and the Sponsor must ensure compliance with the provisions found in this agreement. All cultural resources work must meet reporting guidelines outlined by the Department of Archaeology and Historic Preservation.
