#1: Describe the work accomplished during this reporting period.

All construction elements as shown on the final designs for both projects is complete. All project components of the Alpenview Fish Passage Project, including final planting, was completed in September of 2022. The majority of the Motteler Culvert Replacement Project elements were completed between September and November of 2022. However, due to the early onset of snow, final grading, paving and planting was postponed until 2023. This required a time extension for the larger grant. Final planting occurred in May 2023 and final grading and paving of the new crossing occurred in June 2023. Since that time, we worked to close out the construction contract with the Contractor for the Motteler project. We are still waiting on final L&I release in order to release retainage and final payment to the Contractor. Delays in this process has resulted in additional time extension amendments.
