#1: Describe the work accomplished during this reporting period.

Fish and invertebrate sampling was completed by the end of June. UAV flights to collect aerial imagery and digital surface models was conducted April 29th and September 30th. Spring beach profiles were collected in April and are scheduled to be collected again in October. The Salish Sea Wiki page was created and the draft project plan was also submitted. The beach time-lapse camera was repaired and began taking pictures August 2nd. We began work on developing a SOW for contracting out assistance and analysis with the geomorphic aspects of the study.

#2: Are there any significant challenges that might hinder progress or keep you from meeting your project milestones? If so, please tell us about them.

Yes

It took longer than expected to get the contract finalized and we are behind in forming the technical advisory group and a little behind in getting set up for the sediment tracking, but otherwise mostly on track

#3: Tell us about work planned for the next reporting period.

Over the next reporting period we plan on completing the hiring of a consulting firm to assist with the geomorphic data collection and analysis work, acquiring all of the necessary equipment and supplies for the sediment tracking study and finding a subcontractor to process the invertebrate samples we have collected and will be collecting in 2025. We will also be forming the technical advisory group so we can get input on the geomorphic study and fish and invertebrate sampling data.
